I. THE FOLLOWING QUESTIONS WERE ASKED BY CONTRACTORS:

- Q1:** My request is to add the term or approved equal to Section X for all the Mueller gate valve material. There is only one distributor in Arizona that can bid and sell Mueller gate valves and that would exclude all the other distributors in Arizona including our company from bidding on Section X. Also, the term (Augagrip) is proprietary specification for Mueller valve company that only one distributor in Arizona can bid on. This will cause all the other distributors in Arizona to no bid all the items with the term (Augagrip) Mueller gate valves. We request that the City of Buckeye consider a addendum for all the items in Section X to allow an approved equal to the Mueller gate valves.
- A1:** This request has been approved. The City will allow an approved equal to be bid on any items listed that were specified Mueller. This applies to Mueller items only.

II. AMEND FIRST PARAGRAPH OF SECTION 2: SPECIFICATIONS/SCOPE OF WORK, TO READ:

Provide pricing and availability for the items listed below. Order quantities will be between one (1) and one hundred (100) based on necessity of the department. Liquidated damages of \$10 per day for orders not received within seven (7) days of either verbal or written confirmation by supplier/vendor shall be applied. All items must be the manufacturers specified **with the exception of** Ford items listed in Sections IV, V, VI, VII, and VIII and **Mueller Items listed in Section X**. The City will allow an "approved equal" to be bid on Ford items listed in Sections IV, V, VI, VII, and VIII below and **Mueller items listed in Section X**. No substitutions will be considered for other specified manufacturers.
