Please note that Louis B. Hazelton Memorial Cemetery does **NOT** offer pallbearer services. Please ensure that appropriate arrangements to move a casket are made prior to arriving at the cemetery grounds.

### \*\*\*NOTICE TO FUNERAL ESTABLISHMENTS\*\*\*

Pursuant to Arizona Revised Statute §36-326(A)(1), a burial permit (disposition/transit permit) is required before the final disposition of the remains can be completed. In the event that remains are brought to Louis B. Hazelton Memorial Cemetery without the burial permit as required by State Law, the cemetery will not complete the final disposition of the remains and the remains will need to be immediately returned to the funeral establishment.

To prevent this from happening in the future, **an interment will not be scheduled** until the funeral establishment obtains a valid burial permit. Section 21-4-1(C) of the Buckeye Municipal Code stipulates, "Interment requests shall not be authorized until all fees are paid in full for the plot or without a valid transit permit." Once a copy of the valid burial permit is received along with the request for interment, the interment will be scheduled. Section 21-6-1 (A) of the Buckeye Municipal Code requires funeral establishments to provide temporary grave markers with the name of the deceased, date and mortuary name.
