

RESOLUTION NO. 32-23

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF BUCKEYE, ARIZONA, ADOPTING REVISED FEES FOR THE BUCKEYE MUNICIPAL AIRPORT; PROVIDING FOR REPEAL OF CONFLICTING ORDINANCES; AND PROVIDING FOR SEVERABILITY.

WHEREAS, the Mayor and Council of the City of Buckeye, Arizona (the “Council”), is authorized pursuant to Article 22-11 of the Buckeye City Code to adopt airport fees, and to establish the amounts of such fees; and

WHEREAS, the City’s current airport fee schedule was adopted in March of 2012, pursuant to Resolution No. 30-12; and

WHEREAS, according to the City’s 2022 Rates and Fees Comparison Study, which has been published on the City’s website along with a schedule of proposed new or increased airport fees for more than 60 days, the amounts of several airport fees should be updated from the amounts established in 2012; and

WHEREAS, the Council adopted a notice of intent to adopt new or increased airport fees pursuant to Resolution No. 18-23, and the City has complied with all requirements of A.R.S. § 9-499.15; and

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF BUCKEYE, ARIZONA, as follows:

Section 1. The recitals set forth above are hereby incorporated as if fully set forth herein.

Section 2. The City of Buckeye Airport Fee Schedule set forth in **Exhibit A**, attached hereto, is hereby adopted and shall become effective June 1, 2023 (the “Effective Date”), and all prior rates, fees, and charges for the same airport services and transactions are hereby repealed as of that same date.

Section 3. All resolutions and parts of resolutions in conflict with the provisions of this Resolution are hereby repealed as of the Effective Date, provided that such repeal shall not affect pending actions by the City for enforcement of any outstanding rates, fees, or charges.

Section 4. If any section, subsection, sentence, clause, phrase, or portion of this Resolution is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions thereof.


