*VIOLATIONS ELIGIBLE FOR DEFENSIVE DRIVING SCHOOL

INFORMATION FOR CERTAIN VIOLATIONS

UNDER AGE 18 (FIRST OFFENSE): In addition to the fine, if you are found responsible or plead responsible for a moving violation, you will be required to attend Traffic Survival School (TSS).

A.R.S. 28-448 – FAILURE TO UPDATE ADDRESS: If you provide valid proof of address change filed with MVD, the Court will waive the fine.

A.R.S. 28-6453A & 28-647.1 – RED LIGHT VIOLATION: In addition to the fine, persons found responsible or who plead responsible for either of these red light violations will be required by MVD to complete Traffic Survival School (TSS).

A.R.S. 28-907A – CHILD PASSENGER RESTRAINT: If you show proof of a child passenger restraint system or proof of purchase of a child passenger restraint system, the fine may be reduced to \$0.

A.R.S. 28-2532A – NO VEHICLE REGISTRATION: If you show proof of current registration on the vehicle, this charge will be dismissed.

A.R.S. 28-3151A & 28-3222 – DRIVER LICENSE REQUIREMENT: Upon proof of a current valid driver license, the fine will be waived.

A.R.S. 28-3169A – NO DRIVER LICENSE IN POSSESSION: Dismissed upon proof of driver license valid on the date and time of the violation. Mail or email a legible copy of the front and back of your driver license.

A.R.S. 28-3482A – DRIVING ON SUSPENDED LICENSE (CIVIL): Dismissed upon proof that your unrestricted privilege to drive has been reinstated by MVD.

A.R.S. 28-4135 A, B & C - NO PROOF OF INSURANCE: A violation results in a mandatory fine of \$961 plus a 3-month suspension of driving privileges. If before or on your appearance date you provide proof of insurance that was valid on the DATE and TIME the ticket was issued, the charge will be dismissed. If you did not have insurance on the violation date, you may be eligible for a reduced fine of \$250 if you provide (1) proof that you purchased a six-month policy of insurance, and (2) a copy of your MVD driving record indicating that you have not been found responsible under §28-4135 within the past 24 months (or not more than once in the past 36 months).

NOTICE

You **MUST** respond to this citation on or before your arraignment date.

You must appear in court unless you choose one of the options explained on the back of this page. For directions to the court visit our website or call 623-349-6510.

You must appear in court if your citation was issued as a result of an accident involving death or a serious physical injury.

Failure to appear for a civil violation on or before your arraignment date will result in a default judgment being entered. There will be a \$25.00 default fee added to each charge plus a \$20.00 time payment fee per case. Your case will be sent to a collection agency which will result in additional fees, your credit and vehicle registration may also be affected. In addition, your Arizona State tax returns may also be impacted.

You may use the Defensive Driving Program for only one eligible moving violation code. If you received more than one violation code on your citation, the other violations must be resolved using options 2 or 3 or by appearing in court.
