WHEREAS, in accordance with the provisions of Title 48, Section 616, Arizona Revised Statutes, the Street Lighting Improvement Districts referenced above (the "Districts"); and

WHEREAS, it appears that all notices have been duly published and mailed, as required by law; and

WHEREAS, the Governing Body of each District intends to adopt the fiscal year 2012-13 Final Budget; and

WHEREAS, in the budgets, the Governing Body of each District has filed with the Clerk the annual statements of the costs and expenditures of the District, including the amount of the annual assessment to be established to pay the expenditures of the District and has conducted a hearing on such statements; and

WHEREAS, Maricopa County (the "County") is now the assessing and collecting authority for the District, the Clerk is hereby directed to transmit a certified copy of this Resolution to the Assessor and Board of Supervisors of Maricopa County, Arizona.

Section 1. Budget Adopted. The District Budgets attached hereto as *Exhibit A* and incorporated by reference herein, in the amount of \$20,819.68 for SLID #1, comprised of Sun City Festival Units A1 and B1; in the amount of \$14,519.02 for SLID-2006-001, comprised of VISTA DE MONTANA Phase 1A, 1B, 2, 3; in the amount of \$29,003.15 for SLID 2006-003, comprised of Blue Horizons; in the amount of \$14,174.74 for SLID 2006-007, comprised of Festival Foothills Phase 1; in the amount of \$4,477.64 for SLID 2006-008, comprised of Festival Foothills Phase 2; in the amount of \$9,107.00 for SLID 2006-009, comprised of Crystal Vista; in the amount of \$27,946.24 for SLID 2006-011, comprised of Sun City Festival Units C1 through H1 and Unit V1; in the amount of \$12,503.83 for SLID 2006-015, comprised of Riata West Unit 2; in the amount of \$14,166.13 for SLID 2006-016, comprised of Sonoran Vista Units 1 and 2; in the amount of \$9,274.56 for SLID 2006-017, comprised of Riata West Unit 1; in the amount of \$2,980.43 for SLID 2006-019, comprised of Sun City Festival Units K1, O1, M1, and R1; in the amount of \$849.27 for SLID 2007-001, comprised of Sundance Parcel 27; in the amount of \$2,323.63 for SLID 2007-002, comprised of Sundance Parcel 25; in the amount of \$601.72 for SLID 2007-003, comprised of Sundance Parcel 26; in the amount of \$3,528.24 for SLID 2007-013, comprised of Sun City Festival Units I1 and P1; in the amount of \$7,915.68 for SLID 2007-010, comprised of Watson Estates; and in the amount of \$447.29 for SLID 2011-001, comprised of Sundance/Yuma Commercial, are hereby adopted by each Governing Body of each District as their respective Budget of the District for the fiscal year 2012-13.

Section 2. No Invalidation of Proceedings. No failure by County officials to properly return the delinquent list and no irregularity in the assessment or omission in the same, or irregularity of any kind in any proceedings shall invalidate such proceedings or invalidate any title conveyed by any tax deed, nor shall any failure or neglect of any officer or officers to perform any of the duties assigned to him or to them on the day within time specified work an invalidation of any proceedings or of any such deed or sale or affect the validity of the assessment and levy of taxes or of the judgment or sale by which the collection of the same may be enforced or in any manner affect the lien of the District upon such property for the delinquent annual assessments unpaid thereon, and no overcharge as to part of the assessment or of costs shall invalidate any proceedings for collecting of annual assessment or the foreclosure, and all acts of officers de facto shall be valid as if performed by officers de jure.


Section 3. Conflicting Resolutions Repealed. All resolutions and parts of resolutions in conflict are hereby repealed.
