NOTICE TO CONTRACTORS:

This Amendment forms a part of the Contract and clarifies, corrects, or modifies the original Request for Qualifications documents prepared by the City of Buckeye.

THE FOLLOWING QUESTIONS WERE ASKED BY CONTRACTORS:

- **Q1.** Is QC testing to be included in our proposal? There is no testing bid item.
- **A1.** QC should be included in the proposal as a Lump Sum.
- **Q2.** Bid item 24 calls for 14' wide maintenance road, the plans call for a 16' maintenance road. My takeoff quantity is 1500 SY compared to 1220 SY on the bid schedule.
- **A2.** The maintenance road should be 16' wide, and the quantity of 1500 SY is correct. The Schedule of Values has been revised.
- Q3. Bid item 31 calls for a 6" Frame and cover. Should it be 60"?
- **A3.** 6" refers to the height of the manhole frame. The manufacturer specifications indicate a 4" frame height. The diameter of the cover shall be 30".

- **Q4.** Bid Item 32 calls for a mitered pipe outlet and the plans show a Headwall instead.
- **A4.** Bid to include cost for the headwall as shown per plan.
- **Q5.** There is no bid item for SWPPP. Will there be one added?
- **A5.** SWPPP should be included in the bid as a Lump Sum.
- **Q6.** Will there be a bid item added for roadway excavation and other grading? Or should we include that in the other items?
- **A6.** Roadway grading shall be included with the pavement items.
- Q7. On sheet 8 of the plans where the existing island is being removed, it shows both 6" AC on 12" ABC (call out #1) and "Replace existing Pavement Min 3" or match" (call out #2). The 63 SY (Call out #2) should not be needed. Bid item 13 should be reduced to 20 SY.
- A7. Note 2 shall be removed at the location noted. Revise quantity as noted. Schedule of Values has been revised.
- **Q8.** Bid item 8 states, "Existing Traffic Signal Pole. See Traffic Signal Plan" What does this item entail?
- **A8.** This is labor only, no real cost associated under the Values.
- **Q9.** This project will have earthwork operations. Where should it be accounted for?
- **A9.** Earthwork shall be included with the pavement item.
- **Q10.** Bid item 33, Remove existing trail, will not have a price associated with it, is that correct?
- **A10.** Correct. No price associated with this item.
- **Q11.** Bid item 69 shows 130 SF, and I measure 1175 SF. Please change the bid schedule.
- **A11.** Maintenance road access ramp should be 130 <u>SY</u>, not 130 SF. Schedule of Values has been revised.
