- A1.** No, bid the work as you determine the level of effort. Should unforeseen conditions exist at the time of construction, the contractor may issue an RFI to the City to account for any unforeseen conditions.
- Q2.** On the site visit we were told that the City of Buckeye would be painting the boxes and bollards after they are installed. Please confirm.
- A2.** Yes, painting of newly installed boxes and bollard will be completed by staff as part of their monthly maintenance.
